(TULSA, OKLA., Nov. 8, 2019) Morton Comprehensive Health Services will provide Marketplace Health Insurance enrollment during regular office hours at its main clinic, 1334 N. Lansing Ave., through Dec. 15. Also, Morton will offer additional opportunities for enrollment assistance on two Saturdays, **Nov. 16 and Dec. 14 from 9 a.m. – 1 p.m.** There is no charge for this service.

Morton has certified staff to assist individuals applying for or renewing their health care insurance through the Marketplace exchange.

In addition, through the Ryan White HIV/AIDS program, Morton will offer Marketplace enrollment services for individuals living with HIV/AIDS. Included in this HIV/AIDS program, Morton will provide specific information on coverage for medical care and essential support services.
